Mayor Diaz and KMM Focus on Pedestrian Safety

Take a walk through Perth Amboy's Fink Park any weekday and it will be obvious why this little gem on the corner of Smith Street and Madison Avenue was the perfect place to kick off KMM's Street Corner Safety program. Pedestrians of all ages — parents with strollers and children in tow, teenagers, businesswomen and men, senior citizens — compete with motor vehicles as everybody tries to get where they need to go safely and expeditiously. Thankfully, this busy intersection, and in fact, the entire city, has experienced no major accidents of late.

Mayor Wilda Diaz wants to keep it that way. That's why she teamed with KMM's Executive Director Bill Neary for Street Corner Safety, a campaign to raise awareness

that drivers and pedestrians must behave responsibly.

Diaz noted that a new law requires that drivers stop for pedestrians in crosswalks, adding "pedestrians must behave responsibly, too."

Neary summed it up, "Pedestrians must think before they cross the street. Cross at the corner with a traffic light or in a designated crosswalk. Look both ways. Put away the cell phone and other distractions. Pay attention."

Then, Diaz and Neary handed out approximately 200 bright yellow totes, reflective wrist bands, and printed materials to passersby.



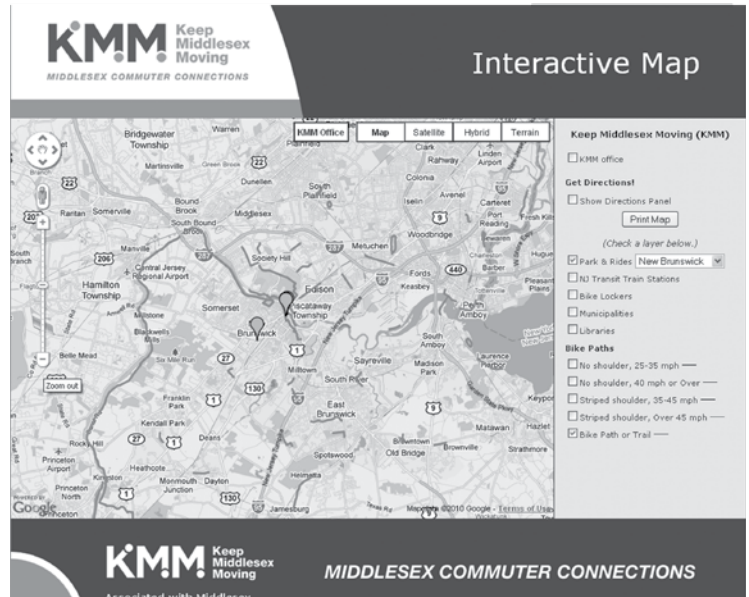

Interactive Transit Map Helps Figure Out How to Get Where You Want to Go

Not sure how to get to your destination by train or bus in Middlesex County? Check out KMM's new interactive map on kmm.org. The map allows users to pinpoint their location and the mass transit available in the area. In addition, the map provides direct access to scheduling and fare information.

The map directs users to mass transit and the many connections available. For example, a commuter who lives in southern Middlesex County and commutes to North Jersey can park at the Exit 8a park and ride lot, take a bus into Newark, and connect to the Northeast Corridor train line in Secaucus Junction instead of driving the turnpike or parkway.

The map also provides the location of bike lockers, bike paths, municipal centers and all libraries in the county. The KMM interactive map is a commuter's friend. Visit the site today and get started on an easier commute.



KMM's Pedestrian Safety Video Premier

Stars and fans turned out for the premier of "The Jay Walker Show," KMM's video about senior citizen pedestrian safety. Approximately 75 people attended the viewing at the North Brunswick Senior Center in October. KMM had obtained a grant from the NJ Division of Highway Traffic Safety to develop the video.

KMM's Executive Director Bill Neary said, "senior citizens are frequent victims of accidents with automobiles. Too often, the pedestrian is at fault because he or she was not following the rules of the road. We wanted to remind seniors of basic pedestrian safety tips in an amusing way."

Talk show host Jay Walker is dismayed to see his guest, star of stage, screen, and soaps, Meryl Street, arrive on stage in a wheelchair. Ms. Street explains that she stepped into the street while talking on her cell phone and was so involved in her conversation, she didn't look left-right-left. She walked right in front of an oncoming car and suffered a broken leg. Ms. Street says she has learned her lesson and is on a mission to teach others how to be responsible pedestrians. She is assisted by a local police officer who joins her onstage.

Gregory Newton, Frank Takacs, and Elaine Schaffer of Playhouse 22 in East Brunswick portrayed the Announcer, Jay Walker, and Meryl Street. Officer Mark Czimar and Ranjit Walia also appeared in the film.

Personal Responsibility Reduces Distracted Driving

When it comes to distracted driving, “personal responsibility is the bottom line,” said U.S. Transportation Secretary Ray LaHood. “When you get behind the wheel of a 5,000 pound automobile, you have a personal responsibility to drive that vehicle safely. That means, put away cell phones and other devices that take your focus off of the road.”

In the fall, KMM joined Secretary LaHood and others across the country to stress

personal responsibility by sponsoring Drive Safe to Work Week. Distracted driving isn’t only texting or phoning. It’s eating, reading a paper, changing a radio station, grooming — anything that takes a driver’s eyes off the road. With so many drivers multitasking behind the wheel, it’s easy to forget that these practices are unsafe.

KMM challenged commuters to take a quiz to assess their distraction potential. Many

people were shocked to learn they are distracted drivers. In fact, 75% of those who took the survey were considered to be “distracted.” KMM also used social media to coach fans on Facebook and Twitter. Upon completion of the week, 193 commuters took a pledge to drive distraction-free.
